**Honorary Members:** Honorary membership in the corporation shall be limited to persons who are judges or justices of the courts of this state or of the United States who reside in or have an office in the State of Connecticut.

**Associate Members:** Associate membership in the corporation shall be limited to (i) persons who are residents of the State of Connecticut and are law students in good standing in law schools which are accredited by the American Bar Association and (ii) other persons who are residents of the State of Connecticut and are employed in a capacity related to the practice of law who meet such qualifications as shall be established from time to time by the Board of Directors of the Corporation. The Board of Directors may establish different categories of Associate Members.
